

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Representative Jerome F. Joaquin to Committee Memberships)**

LEGISLATIVE ORDER NO. 02-457

1 **WHEREAS, on September 9, 2002 Legislative Council Chairwoman Rita Martinez did receive the**
2 **resignation of Gu Achi District Representative to the Tohono O'odham Legislative**
3 **Council Alex J. Ramon, which became effective October 4, 2002; and**

4 **WHEREAS, prior to his resignation, Councilman Ramon served on the Legislative Council**
5 **Cultural Preservation, Appropriations, Health and Human Services, and Human**
6 **Resources Development Committees; and**

7 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council to**
8 **"establish rules and procedures to regulate all meetings of . . . standing committees"**
9 **and to "appoint, or provide for the appointment of, and prescribe the duties and**
10 **powers of committees" (Constitution, Article VI, Section 1(a) and (b)); and**


11 **WHEREAS, as a matter of practice, the Legislative Council has appointed a resigning**
12 **representative's successor to that representative's vacant committee seats.**

13 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that**
14 **it hereby appoints Councilman Jerome F. Joaquin to the Legislative Council Cultural**
15 **Preservation, Appropriations, Health and Human Services, and Human Resources**
16 **Development Committees.**

17 **BE IT FINALLY ORDERED that Legislative Orders No. 01-269, 01-266, 01-284, and 01-273**
18 **(appointing, respectively, Cultural Preservation, Appropriations, Health and Human**
19 **Services, and Human Resources Development Committee members) are hereby**
20 **superceded only to the extent that Councilman Jerome F. Joaquin is appointed to**
21 **former Councilman Alex J. Ramon's vacated Committee memberships effective**
22 **immediately.**

23 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07TH, Day of**
24 **OCTOBER 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) &**
26 **(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
