8		1982 ("SAWRSA"), the Tohono O'odham Nation (the "Nation") received \$15,000,000.00					
9		to be held in trust by the Nation (the "SAWRSA Trust Fund"); and					
10	WHEREAS,	under Section 309 (b) of SAWRSA, the nation may expend accrued interest and					
11		dividends on the SAWRSA Trust Fund " for the subjugation of land, development of					
12		water resources, and the construction, operation, maintenance, and the replacement					
13		of related facilities on the Papago Reservation (now known as the Tohono O'odham					
14		Reservation) which are not the obligation of the United States under this (SAWRSA)					
15		or any other Act of Congress"; and					
16	WHEREAS,	the responsibilities of the San Xavier Cooperative Association Equipment Insurance					
17		Budget qualify for the funding under the SAWRSA Trust Fund; and					
18	WHEREAS,	the San Xavier Cooperative Association has prepared the attached budget for fiscal					
19		year 2003 in the amount of \$5,264.00 and funded from the SAWRSA Trust Fund.					
20	NOW, THER	OW, THEREFORE, BE IT RESOLVED THAT:					
21		1. The Tohono O'odham Legislative Council hereby approves the San Xavier					
22		Cooperative Association Equipment Insurance Budget in the amount of \$5,264.00
