RESOLUTION NO. 02-474

1 WHEREAS, the Legislative Council went into session the week of October 7 - 11, 2002; and
2 WHEREAS, the Legislative Council did hear presentation from the Schuk Toak District on the
3 reason why the District is amending Resolution No. S.T. 09-11-02-32, Continuing
4 Resolution for the Schuk Toak District FY - 2002 Budget and to present the FY-2003
5 Schuk Toak District Budget in the November Legislative Session.

6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
7 accepts and approves the amending continuing resolution for the Schuk Toak
8 District FY - 2002 Budget.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day
10 of OCTOBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
11 AGAINST; -0- NOT VOTING; and [01]ABSENT, pursuant to the powers vested in the Council by Section
12 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
13 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
14 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
15 Stat. 984).
