RESOLUTION NO. 02-478

1 WHEREAS, the Gu-Vo District Governing Council did review the two (2) proposed budgets
2 submitted by District Administration and the other by the District's Budget & Finance
3 (B & F) Committee; and

4 WHEREAS, the Gu-Vo District Governing Council at their regular meeting on the 17th day of
5 September 2002 did adopt the B & F Committee's proposal; and

6 WHEREAS, the Gu-Vo District Governing Council did receive the following funding for the Fiscal
7 Year (FY) 2002/2003 Gu-Vo District budget;

23 thousand one hundred seventy-five dollars 22/100 (646,175.22).

24 BE IT FURTHER RESOLVED that the said FY 2002/2003 Budget may be amended or modified as
25 needed.


26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH. Day

29 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
30 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
31 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
32 18, 1934 (48 Stat. 984).


