RESOLUTION NO. 02-479

1 **WHEREAS, the HICKIWAN District Council held a special meeting on the FY 2003 budget on**
2 **October 08, 2002; and**

3 **WHEREAS, the Tohono O'odham Nation allocated funds to the (11) Districts from Gaming**
4 **Revenues and Mining Royalties; and**

5 **WHEREAS, the HICKIWAN District received \$393,755.14 from the gaming revenues, 30% from the**
6 **Golden Ha:san Casino in the amount of \$48,496.37 and \$51,102.04 from the mining**
7 **royalties totaling \$493,353.55; and**

8 **WHEREAS, the HICKIWAN District maintains accounts held with Wachovia Securities, where these**
9 **funds will be maintained on behalf of the HICKIWAN District; and**


10 **WHEREAS, the District Council has held numerous meetings to discuss the FY 2003 budget of the**
11 **HICKIWAN District; and**

12 **WHEREAS, the HICKIWAN District is in support and approves the FY 2003 budget in the amount**
13 **of \$493,353.55.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **the FY 2003 budget of the HICKIWAN District in the amount of \$493,353.55 which will**
16 **be held in the Wachovia Securities Account for the HICKIWAN District.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
18 **of OCTOBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**
