8		Nation and be confirmed by the Legislative Council; and				
9	WHEREAS,	Flora Manuel is nominated and has sufficient experience, education and dedication				
10		to the improvement of elderly health care for the O'odham to make sound judgments				
11		concerning the operation of the skilled nursing facility; and				
12	WHEREAS,	as a member of the Tohono O'odham Nursing Care Authority Board, the individual				
13		shall help to conduct the business affairs of the Authority.				
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council upon					
15	nomination by the Chairman of the Nation hereby approves the selection of Flora					
16		Manuel, to serve a four year term to expire August 30, 2005 as a Tohono O'odham				
17		Nursing Care Authority Board member.
