

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Larry Garcia as the member to the District Water
Advisory Committee for the Sells District)**

RESOLUTION NO. 02-493

1 **WHEREAS, Section 303 (b)(1) of the Southern Arizona Water Rights Settlement Act of 1982**
2 **authorized a study to determine the availability and suitability of water resources**
3 **within Sells Tohono O'odham Reservation (the "Water Resources Study"); and**

4 **WHEREAS, pursuant to Resolution 19-85 the Tohono O'odham Legislative Council established**
5 **a Water Management Committee, (hereon the District Water Advisory Committee) to**
6 **assist officials of the Tohono O'odham Nation in carrying out the Water Resources**
7 **Study; and**


8 **WHEREAS, under the Bylaws of the District Water Advisory Committee Section 4.4.1, upon**
9 **recommendation of the Chairperson of the Water Resources Committee of the**
10 **Legislative Council, the Chairperson of the Nation shall designate members to the**
11 **District Water Advisory Committee to staggered terms; and**

12 **WHEREAS, the Chairperson of the Water Resources Committee has recommended, and the**
13 **Chairman of the Nation had designated Larry Garcia as the member to the District**
14 **Water Advisory Committee for the Sells District for a term set to expire September 30,**
15 **2004.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appoints**
17 **Larry Garcia to serve as the member to the District Water Advisory Committee for a**
18 **term set to expire September 30, 2004 .**


19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
20 **of OCTOBER, 2002 at a meeting at which a quorum was present with a vote of 1,883.8 FOR; 94.15**
21 **AGAINST; 439.55 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**


