1	WHEREAS,	by Resolution No. 02-492, the Tohono O'odham Legislative Council adopted Bylaws
2		which established the District Water Advisory Committee (the ``Advisory Committee'');

4	WHEREAS,	$funding \ is \ necessary \ to \ enable \ the \ Advisory \ Committee \ to \ satisfy \ the \ responsibilities$
5		assigned in the Bylaws; and
6	WHEREAS,	pursuant to Section 309(a) of the Southern Arizona Water Rights Settlement Act of
7		1982 ("SAWRSA"), the Tohono O'odham Nation (the "Nation") received \$15,000,000 to
8		be held in trust by the Nation (the "SAWRSA Trust Fund"); and
9	WHEREAS,	under Section 309(b) of SAWRSA, the Nation may expend accrued interest and
10		dividends on the SAWRSA Trust Fund "for the subjugation of land, development of
11		water resources, and the construction, operation, maintenance, and replacement of construction and construction constru
12		related facilities on the Papago Reservation (now known as the Tohono O'odham
13		Reservation) which are not the obligation of the United States under this (SAWRSA) or a substitution of the United States and the Sawrana substitution of the United States and Sawrana substitution of
14		any other Act of Congress"; and
15	WHEREAS,	the responsibilities of the Advisory Committee related to development of water
16		resources qualify for funding under the SAWRSA Trust Fund; and
17	WHEREAS,	the Advisory Committee has prepared the attached budget for fiscal year 2003 in the
18		amount of \$121,250 and funded from the SAWRSA Trust Fund; and
19	WHEREAS,	the Water Resources Committee and Budget & Finance Committee recommended
