

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Consolidated Healthy O'odham Promotion Program and Data Improvement Project
FY 2003 Budget (October 1, 2002 - September 30, 2003))

RESOLUTION NO. 02-502

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**
2 **through FY 2004; and**

3 **WHEREAS, by Resolution No. 99-149, the Tohono O'odham Legislative Council approved the**
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**
5 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of**
6 **1997; and**

7 **WHEREAS, by Resolution No. 98-150, the Tohono O'odham Legislative Council approved the**
8 **establishment of the Data Improvement Program under the Special Diabetes**
9 **Programs for Indians, authorized by the Balanced Budget Act of 1997; and**

10 **WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved the**
11 **name change of the Community Based Diabetes Program to the Healthy O'odham**
12 **Promotion Program; and**

13 **WHEREAS, our total monies currently appropriated equal \$4,081,697.27, only \$3,657,859.16 is**
14 **presently budgeted for the 2003 fiscal year, and the remaining amount, \$423,838.11**
15 **will be held in carryover; and**

16 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**
17 **Fiscal Year 2003 of \$3,657,859.16 budget to operate the Healthy O'odham Promotion**
18 **Program.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 20 **1. Approves the Healthy O'odham Promotion Program Fiscal Year 2003 budget for**
21 **\$3,657,859.16.**
- 22 **2. Approves \$423,838.11 to carry over to the following fiscal year, along with the**
23 **NOGA for fiscal year 2003 still to be received.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH. Day**
25 **of OCTOBER, 2002 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 160.7 [02] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**


