
1 **WHEREAS, the following named person(s) have formally relinquished their membership in the**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04th Day**
11 **of NOVEMBER 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
12 **AGAINST; -0- NOT VOTING; and [0] ABSENT, pursuant to the powers vested in the Council by Article**
13 **II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,**
14 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
15 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
16 **of June 18, 1934 (48 Stat. 984).**




