19		2. The Tohono O'odham Legislative Council acknowledges and approves Section
20		14(B) of the Attorney Contract which includes a limited waiver of sovereign
21		immunity for binding arbitration of fee disputes, provided that in no event shall
22		an arbitrator (or arbitration panel) be authorized to make an award of interest
23		or in an amount which, combined with prior payments to the Attorneys, exceeds
24		the contract limitation stated in Paragraph C of Section 3 of the Attorney
25		Contract, as that amount may be modified by mutual consent of the parties.
26		3. Funding for the Attorney Contract shall be provided under the authority of
27		Resolution No. 02-427 in the operating budget of the Office of Attorney General.
28		4. The Chairman of the Nation is authorized and directed to execute the Attorney
