

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 02-493, "Approving the Appointment of Larry Garcia
as the Member to the District Water Advisory Committee for the Sells District")**

RESOLUTION NO. 02-526

1 **WHEREAS, the Legislative Council has established a District Water Advisory Committee whose**
2 **initial membership is comprised of individuals who had previously been appointed**
3 **by the District Councils to serve on the Water Management Committee; and**

4 **WHEREAS, because Water Management Committee members were not appointed to specific**
5 **terms, it was necessary to designate the terms of these individuals upon the creation**
6 **of the District Water Advisory Committee; and**

7 **WHEREAS, the Bylaws of the District Water Advisory Committee provide that the initial**
8 **members' terms shall be designated by the Nation's Chairman upon the**
9 **recommendation of the Legislative Council Water Resources Committee Chairperson**
10 **(Bylaws of the District Water Advisory Committee, Section 4.4); and**

11 **WHEREAS, the Legislative Council Water Resources Committee Chairperson has recommended**
12 **and the Nation's Chairman had designated the terms of the initial members of the**
13 **Advisory Committee; and**

14 **WHEREAS, during the October 2002 Legislative Council General Session, the Council adopted**
15 **Resolution No. 02-493, which approved the "appointment" of Larry Garcia to the**
16 **Advisory Committee; and**

17 **WHEREAS, because legislative action is not required in order to either appoint initial Advisory**
18 **Committee members or to designate the initial members' terms, it is necessary to**
19 **rescind Resolution No. 02-493.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
21 **rescinds Resolution No. 02-493, "Approving the Appointment of Larry Garcia as the**
22 **Member to the District Water Advisory Committee for the Sells District.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH. Day**
25 **of NOVEMBER, 2002 at a meeting at which a quorum was present with a vote of 1,979.75 FOR; -0-**
26 **AGAINST; 437.75 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**






