RESOLUTION NO. 02-531

1 **WHEREAS, the National Congress of American Indians (NCAI) will hold its 59th Annual Session in**
2 **San Diego, California on November 10 - 15, 2002; and**

3 **WHEREAS, the Tohono O'odham Nation is a long time member in good standing with the**
4 **National Congress of American Indians; and**

5 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to renew its membership in the**
6 **National Congress of American Indians.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**

24 **National Congress of American Indians 59th Annual Session.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**
26 **payment of NCAI membership dues for the Tohono O'odham Nation in the amount of**
27 **\$1,000 from the Legislative Branch dues and subscriptions line item.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH. Day**
29 **of NOVEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
31 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**
