


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reappointing Rosemary Lopez to the Tohono O'odham Farming Authority
Management Board)**

RESOLUTION NO. 02-533

1 **WHEREAS, the Second Restated Plan of Operation for the Tohono O'odham Farming Authority**
2 **calls for the appointment of the Directors of the Farming Authority Management**
3 **Board by the Chairman of the Nation, with the approval of the Legislative Council; and**
4 **WHEREAS, Rosemary Lopez has been nominated by the Chukut Kuk District to represent the**
5 **District as a Director on the Board; and**
6 **WHEREAS, the Chairman of the Nation has appointed Ms. Lopez to serve as a Director**
7 **representing the Chukut Kuk District in accordance with Section 4.1.1 and 4.3 of the**
8 **Second Restated Plan of Operation for the Tohono O'odham Farming Authority; and**
9 **WHEREAS, Ms. Lopez agrees to serve as a Director for a term set to expire 08-31-2005.**
10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
11 **reappointment of Rosemary Lopez to serve as a Director on the management board**
12 **of the Tohono O'odham Farming Authority as the Chukut Kuk representative for a**
13 **term set to expire August 31, 2005.**


14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
15 **of NOVEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-**
16 **AGAINST; 160.7 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**


