

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reappointing Julia Felix to the Tohono O'odham Farming Authority Management Board)**

RESOLUTION NO. 02-534

1 WHEREAS, the Second Restated Plan of Operation for the Tohono O'odham Farming Authority
2 calls for the appointment of the Directors of the Farming Authority Management
3 Board by the Chairman of the Nation, with the approval of the Legislative Council; and

4 WHEREAS, Julia Felix has been nominated by the Schuk Toak District to represent the District
5 as a Director on the Board; and


6 WHEREAS, the Chairman of the Nation has appointed Ms. Felix to serve as a Director
7 representing the Schuk Toak District in accordance with Section 4.1.1 and 4.3 of the
8 Second Restated Plan of Operation for the Tohono O'odham Farming Authority; and

9 WHEREAS, Ms. Felix agrees to serve as a Director for a term set to expire 08-31-2005.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
11 reappointment of Julia Felix to serve as a Director on the management board
12 of the Tohono O'odham Farming Authority as the Schuk Toak representative for a
13 term set to expire August 31, 2005.


14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day
15 of NOVEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-
16 AGAINST; 160.7 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
17 Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
18 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
20 Stat. 984).


