

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2003 Commerce Committee Budget)**

**RESOLUTION NO. 02-538**

1 **WHEREAS, the Legislative Council Commerce Committee has submitted an FY 2003 committee**  
2 **budget for the purposes of attending meetings with Arizona officials, National Indian**  
3 **Gaming Association (NIGA), and other Indian gaming-related conferences and**  
4 **meetings; and**

5 **WHEREAS, this budget, as attached and incorporated by this reference, is in the amount of**  
6 **\$63,000.00.**


7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
8 **approves the Commerce Committee's FY 2003 Budget in the amount of \$63,000.00.**

9 **BE IT FURTHER RESOLVED that the Commerce Committee's FY 2003 Budget shall be an operating**  
10 **expense of the Tohono O'odham Gaming Authority.**


11 **BE IT FINALLY RESOLVED that the Tohono O'odham Gaming Authority shall be billed on a**  
12 **quarterly basis for expenditures made pursuant to the Commerce Committee's FY**  
13 **2003 Budget.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day**  
16 **of NOVEMBER, 2002 at a meeting at which a quorum was present with a vote of 1,617.7 FOR; 799.8**  
17 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**


