

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of No-Cost Grant Extensions for Brownfields Pilot Project Account #11-5102)

RESOLUTION NO. 02-544

1 WHEREAS, the TONEPA requested a no-cost extension on September 9, 2002 to US EPA for the
2 Brownfields Pilot Project (#3, BP-989189-01); and

3 WHEREAS, the extension will allow TONEPA staff to complete the current work plan tasks; and

4 WHEREAS, the US EPA has offered an extension until September 30, 2003 for the continuance of
5 the Brownfields Economic Redevelopment Initiative Grant Project (Assistance
6 Amendment #3, BP-98918901-3); and

7 WHEREAS, there is \$128,231.01 (Account #11-5102) in savings to continue the program; and

8 WHEREAS, the program period has been changed from October 01, 1998 through September 30,
9 2003.


10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts
11 Assistance Amendment #3, BP-989189-3 for the Brownfields Pilot Project which
12 modifies the project period to October 01, 1998 through September 30, 2003.

13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council, the Chairman is
14 authorized to negotiate and execute the grant, provided however, that any
15 amendments affecting the funding of funding levels of the grant shall be submitted
16 for further prior approval.

17 BE IT FINALLY RESOLVED that the TONEPA is authorized to expend all available funds awarded
18 pursuant to Cooperative Agreement BP-98918901-3.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day
20 of NOVEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
21 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by
22 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
23 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
25 Stat. 984).


