1	WHEREAS,	the Tohono O'odham Nation owns a building, commonly known as the Elderly
2		Building (the "Building"), which has been abandoned for approximately fifteen (15
3		years, and is generally and legally described as of approximately 2,050 square fee
4		and located in South Komelic, Arizona (NE1/4, NE1/4, NE1/4, Sec. 6, T20, R6); and
5	WHEREAS,	the Community of South Komelic has expressed a desire to own the Building for the
6		purposes of providing space for community functions and wellness type activities
7		and
8	WHEREAS,	the transfer of any rights, title and interest in the Building are subject to the
9		agreement of the Community of South Komelic (the "Liability Waiver Agreement"
10		attached in the form hereto and incorporated by this reference) to release the
11		Tohono O'odham Nation from any liability or loss related to the Building or any
12		environmental condition alleged to be present in or around the Building or to any use
13		of the Building or any special, incidental, exemplary or consequential damages of any
14		kind regardless of the form of action, whether in contact, tort (including negligence)
15		or otherwise, related to the Building, its structure, foundation, or any fixture within
16		or arising from the Community of South Komelic's use or ownership of the Building
17	NOW, THER	EFORE, BE IT RESOLVED that:
18		1. The Tohono O'odham Legislative Council hereby transfers all rights, title and
19		interest in the Elderly Building (the "Building"), generally and legally described
20		as of approximately 2,050 square feet and located in South Komelic, Arizona
21		(NE1/4, NE1/4, NE1/4, Sec. 6, T20, R6) to the Community of South Komelic for the

- 2. In exchange for the purchase price of one dollar, the Building is hereby transferred to the Community of South Komelic as is. The Nation makes no warranty of any kind, express or implied regarding the Building.
- 3. The transfer of all rights, title and interest in the Building may only become effective upon the express agreement of the Community of South Komelic to the

1	terms and conditions of the Liability Waiver Agreement.
2	4. This transfer of all rights, title and interest in the Building shall be governed by
3	and construed in accordance with the laws of the Tohono O'odham Nation. Any
4	dispute arising under this transfer shall be resolved in the Courts of the Nation,
5	provided that nothing herein shall be interpreted as an express or implied waiver
6	of the Nation's immunity from suit in any forum or in any jurisdiction.
