

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with Law Firm of Shelley, Bethea, Gillette & Clark)**

RESOLUTION NO. 02-574

1 WHEREAS, it is advisable that the Human Resources Office has available independent legal
2 representation for employment issues in which the Office of Attorney General is
3 unable to provide legal advice due to conflicts of interest; and

4 WHEREAS, the Human Resources Office recommends an Attorney Contract with the law firm of
5 Shelley, Bethea, Gillette & Clark (the "Attorneys") to provide legal representation to
6 the Human Resources Office for the foregoing purposes; and

7 WHEREAS, the proposed Attorney Contract is in the amount of \$10,500 for the period from
8 October 1, 2002 through September 30, 2003; and

9 WHEREAS, the proposed Attorney Contract is in the amount of \$10,500 for the period from
10 October 1, 2002 through September 30, 2003; and

11 WHEREAS, the operating budget for the Human Resources Office (Account No. 01-1005-810) for
12 fiscal year 2003 includes sufficient funds for the Attorney Contract; and


13 WHEREAS, the Domestic Affairs Committee and the Human Resources Development Committee
14 recommend approval by the Legislative Council of an Attorney Contract.

15 NOW, THEREFORE, BE IT RESOLVED THAT:

- 16 1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract
17 with the law firm of Shelley, Bethea, Gillette & Clark in the amount of \$10,500 for
18 the fiscal year ending September 30, 2003 and in the form attached hereto.
- 19 2. Funding for the Attorney Contract in fiscal year 2003 shall be provided under the
20 operating budget of the Human Resources Office (Account No. 01-1005-810).
- 21 3. The Chairman of the Nation is authorized and directed to execute the Attorney
22 Contract.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND. Day
24 of DECEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,229.2 FOR; -0-
25 AGAINST; -0- NOT VOTING; and 188.3 [03] ABSENT, pursuant to the powers vested in the Council by
26 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
27 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).
