

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Xavier District FY 2003 Budget)**

RESOLUTION NO. 02-577

1 **WHEREAS, the San Xavier District Council has reviewed the projected expenditures for fiscal**
2 **year 2003 and has determined that the budget components are essential to meeting**
3 **the needs of the San Xavier District Community; and**

4 **WHEREAS, the San Xavier District Council intends to utilize its gaming revenues to meet the**
5 **projected budget amount outlined in the attached fiscal year 2003 budget; and**

6 **WHEREAS, the proposed budget has been reviewed and approved by majority vote of the San**
7 **Xavier District members present at the Special District Community meeting held on**
8 **November 16, 2002; and**

9 **WHEREAS, the total budget amount is four million two hundred thirty three thousand four**
10 **hundred thirty two dollars and fifty cents (\$4,233,432.50).**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **approves the San Xavier District's fiscal year 2003 budget in the amount of four**
13 **million two hundred thirty three thousand four hundred thirty two dollars and fifty**
14 **cents (\$4,233,432.50).**

15 **BE IT FINALLY RESOLVED that \$958,924.31 of the total \$4,233,432.50 District FY 2003 budget shall**
16 **be funded from the San Xavier District savings account.**


17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day**

19 **AGAINST; 416.1 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**


