

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Wildlife & Vegetation Management Program FY 2003 Dedicated
Revenue Account Budget)**

RESOLUTION NO. 02-582

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 2000-276 established the Wildlife**
2 **& Vegetation Management Program within the Natural Resources Department; and**

3 **WHEREAS, one of the stated objectives of the Wildlife & Vegetation Management Program is to**
4 **"seek funding from outside sources to enhance its ability to meet its goals and reduce**
5 **the Nation's financial commitment for its operation;" and**

6 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 2000-277 established a Dedicated**
7 **Revenue Account (Account #44-1511) for the deposit of funds received by the Wildlife**
8 **& Vegetation Management Program from outside sources and authorized the**
9 **Program to expend these funds for operational purposes consistent with approved**
10 **budgets.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **authorizes the Wildlife & Vegetation Management Program to expend \$29,200.00 in**
13 **its Dedicated Revenue Account as itemized in the attached FY 2003 Budget.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day**
15 **of DECEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**


