

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2003 Department of Human Services - Division of Health
Transportation Service Third Party Revenue Budget)

RESOLUTION NO. 02-584

1 **WHEREAS, the Tohono O'odham Nation continues to provide medically necessary transportation**
2 **to members and residents of the Nation, collecting third party reimbursements**
3 **where applicable; and**

4 **WHEREAS, there is a need to budget FY 2002 Third Party Revenue funds in the amount of**
5 **\$363,410.20 to supplement the operational costs of Health Transportation Service**
6 **Division; and**

7 **WHEREAS, the Legislative Council, through Resolution No. 2000-258 approved that all third party**
8 **reimbursement funds obtained by the Division of Health Transportation Service be**
9 **applied to the program's base budget and utilized for program operations; and**

10 **WHEREAS, the Division of Health Transportation Service has sufficient funds deposited with the**
11 **Nation's Accounting Department to cover the proposed budget amount of**
12 **\$363,410.20; and**

13 **WHEREAS, a Third Party Revenue budget for FY 2003 has been submitted for review and approval**
14 **by the Department of Human Services for the Division of Health Transportation**
15 **Service.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **approves:**

- 18 **1. The attached Third Party Revenue budget as submitted to supplement the FY 2003**
19 **Health Transportation Service Base budget.**
- 20 **2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman**
21 **and any designated Official is hereby authorized to negotiate and execute**
22 **contracts and expend funds associated with this budget.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day**
24 **of DECEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
