10		including two (2) new field vehicles and computer upgrades due to product
11		unavailability and can now be accomplished using carry over funds from FY 2002; and
12	WHEREAS,	the Water Projects Office has presented this modification to the appropriate
13		committees and the committees wish to bring it before the Legislative Council.
