

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract Amendment with the Law Firm of Hobbs, Straus,**  
**Dean & Walker, L.L.P.)**

RESOLUTION NO. 02-596

1 **WHEREAS, by Resolution No. 02-462, the Tohono O'odham Legislative Council did approve an**  
2 **Attorney Contract (the "Contract") with the law firm of Hobbs, Straus, Dean & Walker,**  
3 **L.L.P.; and**

4 **WHEREAS, the Contract was limited to a budget of \$50,000; and**

5 **WHEREAS, additional services are required by and of the Attorneys for continuing matters**  
6 **related to the declination by the U.S. Bureau of Indian Affairs of the Nation's proposal**  
7 **to extend BIA Master Contract 1450CTH54T61071; and**

8 **WHEREAS, it has been estimated by the Office of the Attorney General that an additional \$100,000**  
9 **may be required for the additional services; and**

10 **WHEREAS, an Amendment No. 1 has been proposed by the Office of the Attorney General as**  
11 **attached and incorporated by this reference; and**

12 **WHEREAS, the Budget and Finance Committee recommends approval of Amendment No. 1 to the**  
13 **Attorney Contract.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 **1. The Tohono O'odham Legislative Council hereby approves, in the form attached**  
16 **hereto, Amendment No. 1 to the Attorney Contract with the law firm of Hobbs,**  
17 **Straus, Dean & Walker in the amount of \$100,000; and**
- 18 **2. The Chairman of the Nation is authorized and directed to execute the foregoing**  
19 **Amendment No. 1 to the Attorney Contract.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
21 **of DECEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,250.2 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and 167.3 [06] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
