
1 **WHEREAS, the Legislative Council held their regular meeting the week of December 2-6, 2002,**  
2 **with a quorum present; and**

3 **WHEREAS, the Legislative Council did hear a presentation from the Schuk Toak District,**  
4 **requesting carry over of the remaining balance of the Supplement Budget in the total**  
5 **amount of \$124,010.30 to complete their home renovation projects.**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Legislative Council does**  
7 **hereby approve the Schuk Toak District Supplement Budget Carry Over, in the total**  
8 **amount of \$124,010.30 and the duration of the Supplement Budget is hereby extended**  
9 **through September 30, 2003.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
11 **of DECEMBER, 2002 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
12 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
13 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
16 **18, 1934 (48 Stat. 984).**




