

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Richard Saunders to the Tohono O'odham Boxing Commission as an  
Initial Commissioner)**

RESOLUTION NO. 02-606

1 WHEREAS, the Ordinance for the Regulation of Professional Boxing Matches Within the Tohono  
2 O'odham Nation, Ordinance Number 02-01, as amended, calls for the appointment  
3 of commissioners to the Tohono O'odham Boxing Commission; and


4 WHEREAS, the Chairman of the Nation has appointed Richard Saunders to serve as an initial  
5 commissioner of the Tohono O'odham Boxing Commission; and

6 WHEREAS, Richard Saunders agrees to serve as an initial commissioner of the Tohono O'odham  
7 Boxing Commission.

8 NOW, THEREFORE, BE IT RESOLVED THAT the Legislative Council approves the appointment of  
9 Richard Saunders to serve as an initial commissioner of the Tohono O'odham Boxing  
10 Commission. Mr. Saunders' term shall commence December 13, 2002, and shall  
11 expire on the third Monday in January 2003.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day  
13 of DECEMBER, 2002 at a meeting at which a quorum was present with a vote of 1,528.9 FOR; 888.6  
14 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by  
15 Section 1 (b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
16 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).
