12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
13 **of [ANUARY 2003] at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
14 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
15 **II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,**
16 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
17 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
18 **of June 18, 1934 (48 Stat. 984).**


