12	WHEREAS,	the Agriculture Committee has discussed and recommends to the Tohono O'odham
13		Legislative Council the appointment of Frances G. Antone as the Tohono O'odham
14		Nation's representative and also hereby appoints Mary Flores as alternate
15		representative to the Southwest Indian Agriculture Association (SWIAA); and
16	WHEREAS,	membership dues for the Tohono O'odham Nation in the amount of two hundred
17		dollars (\$200.00) for calendar year 2003 are due and payable.

19		the Nation's membership in the Southwest Indian Agriculture Association (SWIAA)
20		and authorizes payment of annual membership dues in the amount of two hundred
