

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting the Election Board's Initiative Budget Supplemental Request in the
Amount of \$24,427.48)**

RESOLUTION NO. 03-014

1 **WHEREAS, the Tohono O'odham Election Board filed a valid Initiative Petition ("IN-03-02"),**
2 **entitled, "Adopting Cultural Center/Museum Site Legislative Council Resolution No.**
3 **2000-275 appropriating \$15,191,080.00 for the construction, staffing and operation**
4 **of a Cultural Center Museum"; and**

5 **WHEREAS, the Tohono O'odham Election Board did prepare and present a Fiscal Year 2003**
6 **supplemental funding request in the amount of \$24,427.28 (the "Supplemental**
7 **Budget") for the purposes of IN-03-02, as attached and incorporated by this reference;**
8 **and**

9 **WHEREAS, funds exist under the budget for the Office of the Chairman - Special Counsel**
10 **("Account 01-3037"), as appropriated by Legislative Resolution No. 02-462; and**


11 **WHEREAS, the Legislative Committees of Rules and Budget and Finance, and the Executive Office**
12 **of the Chairman recommend approval of the Supplemental Request.**

13 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 14 **1. For the purposes of funding the Supplemental Budget, \$24,427.48 is hereby de-**
15 **obligated from Account 01-3037.**
- 16 **2. The Supplemental Budget is approved and the Election Board is authorized to**
17 **expend \$24,427.48 according to the attached budget, as appropriated from**
18 **Account 01-3037.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH. Day**
20 **of JANUARY, 2003 at a meeting at which a quorum was present with a vote of 1,904.6 FOR; -0-**
21 **AGAINST; 512.9 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**




