

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2003 Low Income Home Energy Assistance Program - Budget Modification #2-
Account Number 12-1310)**

RESOLUTION NO. 03-017

1 **WHEREAS, Low Income Home Energy Assistance funds have been made available to the Tohono**
2 **O'odham Nation for FY 2003 through the State of Arizona, Department of Commerce;**
3 **and**

4 **WHEREAS, the Tohono O'odham Nation's application for FY 2003 funding was approved through**
5 **the State of Arizona, Department of Commerce in the amount of \$53,980.00 for**
6 **contract period of July 01, 2002 to June 30, 2003; and**

7 **WHEREAS, any amendments affecting the funding of funding levels of the contract shall be**
8 **submitted for review and approval by the Tohono O'odham Legislative Council; and**

9 **WHEREAS, the Low Income Home Energy Assistance Program has submitted the attached budget**
10 **modification #2 for review and approval. The budget modification #2 deletes the**
11 **salary line item and adds a new line item of Supplies - Office. The grand total amount**
12 **of the budget remains the same (\$53,980.00).**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 14 **1. It hereby approves and authorizes budget modification #2 and authorizes**
15 **expenditures in accordance with the attached budget; and**
16 **2. The Tohono O'odham Nation's officials to wit: The Chairman is hereby authorized**
17 **to negotiate and execute the contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
19 **of JANUARY, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**




