

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Extending Resolution No. 02-593 for FY 2002 Continuing Authorization for the Special
Projects Office for the Period of January 10, 2003 through March 07, 2003)

RESOLUTION NO. 03-018

1 **WHEREAS, the current fiscal year expired on September 30, 2002 upon which the authority of the**
2 **Tohono O'odham Nation Government to expend appropriated funds also ceased; and**

3 **WHEREAS, the leadership of the Nation continues to examine the fiscal requirements of all**
4 **operations and capital projects; and**

5 **WHEREAS, it is in the best interest of the Nation to enact the necessary authority to permit the**
6 **Special Projects Office to continue operations.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
8 **authorizes the Special Projects Office to expend funds to continue all operations and**
9 **approved projects at FY 2002 level.**

10 **BE IT FURTHER RESOLVED that the Special Projects employees compensation shall remain at**
11 **current levels until such time that the Special Projects fiscal year 2003 budget is**
12 **formally adopted which may authorize, retroactive to October 01, 2002.**

13 **BE IT FINALLY RESOLVED that this continuing authorization re-affirms the authority of the Special**
14 **Projects to expend funds appropriated for capital projects.**


15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
16 **of JANUARY, 2003 at a meeting at which a quorum was present with a vote of 1,250.45 FOR; 982.35**
17 **AGAINST; 184.7 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**


