

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract with the Law Offices of Rolando Ballesteros Navarro**  
**Related to Initiative Business Grants)**

**RESOLUTION NO. 03-022**

1 **WHEREAS, the Tohono O'odham Legislative Council appropriated \$15 million for business**  
2 **grants to enrolled members of the Tohono O'odham Nation, as authorized under an**  
3 **Initiative (IN-01-97); and**

4 **WHEREAS, the Legislative Council has approved the fiscal year 2003 budget for the Economic**  
5 **Development Department (the "Department") related to the Department's**  
6 **administration of the grant program in Mexico; and**

7 **WHEREAS, the Department, grantees and grant applicants require advice on the laws applicable**  
8 **to businesses situated in Mexico; and**

9 **WHEREAS, the approved budget of the Department includes funds to engage attorneys for that**  
10 **purpose (24-1813.810); and**

11 **WHEREAS, the Department recommends the continuing representation of the Law Office of**  
12 **Rolando Ballesteros Navarro for program matters related to Mexico; and**

13 **WHEREAS, an Attorney Contract with the Law Office of Rolando Ballesteros Navarro in the**  
14 **amount of \$60,000.00 has been prepared, copies of which are attached; and**

15 **WHEREAS, the Domestic Affairs and Commerce Committees recommend approval of the**  
16 **Attorney Contract.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT:**

18 **1. The Tohono O'odham Legislative Council approves, in the form attached hereto,**  
19 **an Attorney Contract with the Law Office of Rolando Ballesteros Navarro in the**  
20 **amount of \$60,000 for fiscal year 2003 and payable from the fiscal year 2003**  
21 **budget of the Economic Development Department (Account No. 24-1813.810).**

22 **2. The Chairman of the Nation is authorized and directed to execute the foregoing**  
23 **Attorney Contract.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>. Day**  
25 **of JANUARY, 2003 at a meeting at which a quorum was present with a vote of 1,516.9 FOR; 400.85**  
26 **AGAINST; 499.75 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (d)(2)&(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**
