

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment No. 1 to the Fiscal Year 2003 Budget of Office of Attorney  
General Adding Recruitment Expense Line Item)**

**RESOLUTION NO. 03-025**

1 **WHEREAS, there is a vacancy in one of the Assistant Attorney General positions in the Office of**  
2 **Attorney General; and**

3 **WHEREAS, the fiscal year 2003 budgets for Executive Branch programs do not include funding**  
4 **for the Recruitment Expense (680) line item; and**

5 **WHEREAS, the Office of Attorney General is unable to conduct a national search for candidates**  
6 **without funds to pay the costs of advertising in publications with national coverage**  
7 **and travel expenses of candidates selected for personal interviews in the Office; and**

8 **WHEREAS, the Attorney General recommends adding a Recruitment Expense (680) line item to**  
9 **the Office of Attorney General budget for fiscal year 2003 in the amount of \$4,000; and**

10 **WHEREAS, the Recruitment Expense line item would be funded by a transfer of \$4,000 from the**  
11 **Professional Services (810) line item in the Office budget; and**

12 **WHEREAS, reducing the Professional Services line item by \$4,000 will leave sufficient funds**  
13 **available for attorney contracts in fiscal year 2003; and**

14 **WHEREAS, attached hereto is an analysis and justification for Amendment No. 1 to the Office of**  
15 **Attorney General fiscal year 2003 budget which would accomplish the above**  
16 **purposes; and**

17 **WHEREAS, the Domestic Affairs Committee and the Budget & Finance Committee recommend**  
18 **approval by the Legislative Council of Amendment No. 1.**

19 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 20 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the fiscal**  
21 **year 2003 budget of the Office of Attorney General (01-1031) which establishes a**  
22 **new line for Recruitment Expense (680) in the amount of \$4,000 and funds the line**  
23 **item by a transfer of \$4,000 from Professional Services (810).**
- 24 **2. The Nation's Accounting Department is authorized and directed to modify the**  
25 **fiscal year 2003 budget of the Office of Attorney General in accordance with**  
26 **Amendment No. 1.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>. Day**  
28 **of JANUARY, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**




