RESOLUTION NO. 03-035

1 **WHEREAS, the Legislative Council went into General Session the week of January 6-10, 2003; and**
2 **WHEREAS, the Legislative Council observed presentation from the Schuk Toak District on**
3 **Fresnal Community Carry Over Supplement Budget request in the total amount of**
4 **\$30,018.45, which will bring the total amount to \$154,028.75, including the**
5 **\$124,010.30 already approved in December 5, 2002 by Legislative Resolution No. 02-**
6 **597; and**
7 **WHEREAS, the duration of the Carry Over Supplement Budget request will commence on January**
8 **15, 2003 through September 30, 2003.**
9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
10 **Carry Over Supplement Budget for the Fresnal Community, in the total amount of**
11 **\$30,018.45.**


12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
13 **of JANUARY, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
14 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**
