(Amending Resolution No. 02-606 to Extend the Term of the Appointment
of Richard Saunders to the Tohono O'odham Boxing Commission as an
Initial Commissioner)

RESOLUTION NO. 03-040

1 **WHEREAS, by Resolution No. 02-606, Richard Saunders was appointed to serve as an initial**
2 **commissioner of the Tohono O'odham Boxing Commission for a term which will**
3 **expire on the third Monday in January 2003; and**

4 **WHEREAS, it is in the interests of the Nation to extend the term of the appointment of Richard**
5 **Saunders to the Tohono O'odham Boxing Commission as an initial commissioner; and**

6 **WHEREAS, Richard Saunders agrees to extend his term as an initial commissioner of the Tohono**
7 **O'odham Boxing Commission.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
9 **Resolution No. 02-606 to extend the term of the appointment of Richard Saunders to**
10 **the Tohono O'odham Boxing Commission as an Initial Commissioner. Mr. Saunders'**
11 **term is hereby extended to March 28, 2003.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
13 **of JANUARY, 2003 at a meeting at which a quorum was present with a vote of 1,689.6 FOR; 727.9**
14 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**


