

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 02-607 to Extend the Term of the Appointment
of Daniel Jones to the Tohono O'odham Boxing Commission as an
Initial Commissioner)**

RESOLUTION NO. 03-041

1 **WHEREAS, by Resolution No. 02-607, Daniel Jones was appointed to serve as an initial**
2 **commissioner of the Tohono O'odham Boxing Commission for a term which will expire**
3 **on the third Monday in January 2003; and**

4 **WHEREAS, it is in the interests of the Nation to extend the term of the appointment of Daniel Jones**
5 **to the Tohono O'odham Boxing Commission as an initial commissioner; and**

6 **WHEREAS, Daniel Jones agrees to extend his term as an initial commissioner of the Tohono**
7 **O'odham Boxing Commission.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
9 **Resolution No. 02-607 to extend the term of the appointment of Daniel Jones to the**
10 **Tohono O'odham Boxing Commission as an Initial Commissioner. Mr. Jones' term is**
11 **hereby extended to March 28, 2003.**


12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH, Day**

15 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**


