

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 02-608 to Extend the Term of the Appointment
of Sial Thonolig to the Tohono O'odham Boxing Commission as an
Initial Commissioner)**

RESOLUTION NO. 03-042

1 WHEREAS, by Resolution No. 02-608, Sial Thonolig was appointed to serve as an initial
2 commissioner of the Tohono O'odham Boxing Commission for a term which will expire
3 on the third Monday in January 2003; and

4 WHEREAS, it is in the interests of the Nation to extend the term of the appointment of Sial
5 Thonolig to the Tohono O'odham Boxing Commission as an initial commissioner; and

6 WHEREAS, Sial Thonolig agrees to extend his term as an initial commissioner of the Tohono
7 O'odham Boxing Commission.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends
9 Resolution No. 02-608 to extend the term of the appointment of Sial Thonolig to the
10 Tohono O'odham Boxing Commission as an Initial Commissioner. Mr. Thonolig's term
11 is hereby extended to March 28, 2003.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day
13 of JANUARY, 2003 at a meeting at which a quorum was present with a vote of 1,689.6 FOR; 727.9
14 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).


