## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Adopting "Tohono O'odham Nation Board Appointment Guidelines")

RESOLUTION NO. 03-044

1	WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,
2	appoint, or provide for the appointment of, and prescribe the duties and powers of
3	committees, boards, officers and agents "(Constitution of the TohonoO'odhamNation,
4	Article VI, Section 1(b)); and
5	WHEREAS, the Nation's Legislative and Executive branches have recognized the need to establish
6	a uniform procedure for appointing board members that will ensure that board
7	vacancies are filled by qualified individuals in a timely manner; and
8	   WHEREAS,   the Legislative Council Rules Committee, having been delegated authority to review
9	and recommend appropriate legislative action regarding the Nation's boards and
10	commissions, has developed the "Tohono O'odham Nation Board Appointment
11	Guidelines" ("Guidelines") to provide a more uniform board appointment procedure;
12	and
13	WHEREAS, a draft of the Guidelines was reviewed with the Legislative Council during the
14	December 2002 General Session and the Council's recommendations have been
15	incorporated; and
16	WHEREAS, the Guidelines have also been reviewed by the Nation's Chairman and further
17	amendments have been made in response to the Chairman's recommendations.
18	NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby adopts the attached
19	Tohono O'odham Nation Board Appointment Guidelines, which shall become effective
20	March 15, 2003.
