

1 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place  
2 the names of each applicant upon the membership roll of the Tohono O'odham  
3 Nation in accordance with Sections 2 and 3 of Article X of the Enrollment  
4 Ordinance.

5 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> Day  
6 of FEBRUARY, 2003 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-  
7 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
8 Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'odham  
9 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting  
10 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
11 of the Act of June 18, 1934 (48 Stat. 984).


