9 membership roll.


10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day

13 II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,
14 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
15 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
16 of June 18, 1934 (48 Stat. 984).


