

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Reappointment of Ronald George Steele to the Tohono O'odham  
Gaming Authority Management Board)**

RESOLUTION NO. 03-066

1 WHEREAS, by Resolution No. 93-311, the Legislative Council chartered the Tohono O'odham  
2 Gaming Authority and established the Gaming Authority Management Board; and

3 WHEREAS, under Section 5(a)(2) of the Gaming Authority Charter, the Chairman of the Nation has  
4 the power to appoint Directors to the Management Board, with the approval of the  
5 Legislative Council; and

6 WHEREAS, by Resolution No. 02-268, Ronald George Steele was appointed and approved to serve  
7 a term set to expire on September 30, 2002; and

8 WHEREAS, the Chairman of the Nation has reappointed Ronald George Steele to a three year term  
9 set to expire September 30, 2005; and

10 WHEREAS, Ronald George Steele agrees to serve on the Gaming Authority Management Board;  
11 and

12 WHEREAS, the Legislative Council Committees of Rules and Commerce have reviewed the  
13 Chairman's reappointment of Ronald George Steele.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
15 the Chairman's reappointment of Ronald George Steele as Director of the Tohono  
16 O'odham Gaming Authority Management Board for a term expiring September 30,  
17 2005.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day  
19 of FEBRUARY, 2003 at a meeting at which a quorum was present with a vote of 1,672.2 FOR; 416.1  
20 AGAINST; 184.7 NOT VOTING; and 144.5 [05] ABSENT, pursuant to the powers vested in the Council  
21 by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
22 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
24 18, 1934 (48 Stat. 984).


