

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Appointment of Mary Narcho to the Tohono O'odham Gaming  
Authority Management Board)**

**RESOLUTION NO. 03-068**

1 **WHEREAS, by Resolution No. 93-311, the Legislative Council chartered the Tohono O'odham**  
2 **Gaming Authority and established the Gaming Authority Management Board; and**

3 **WHEREAS, under Section 5(a)(2) of the Gaming Authority Charter, the Chairman of the Nation**  
4 **appoints Directors to the Management Board, with the approval of the Legislative**  
5 **Council; and**

6 **WHEREAS, by Resolution No. 95-098, Barbara Enos was appointed and approved to serve a term**  
7 **set to expire on September 30, 1997; and**

8 **WHEREAS, by Resolution No. 02-294, Ms. Enos holds over until her successor has been appointed**  
9 **and qualified; and**

10 **WHEREAS, the Chairman of the Nation has appointed Mary Narcho to succeed Ms. Enos on the**  
11 **Gaming Authority Management Board; and**

12 **WHEREAS, Mary Narcho agrees to serve on the Gaming Authority Management Board; and**

13 **WHEREAS, the Legislative Council Committees of Rules and Commerce have reviewed the**  
14 **Chairman's appointment of Mary Narcho.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
16 **the Chairman's appointment of Mary Narcho as a Director of the Tohono O'odham**  
17 **Gaming Authority Management Board for a term expiring September 30, 2003.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day**  
19 **of FEBRUARY, 2003 at a meeting at which a quorum was present with a vote of 2,273.0 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and 144.5 [04] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat. 984).**


