

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Appointing Janice Aldrich to the Tohono O'odham Ki:Ki Association Board of Directors)**

RESOLUTION NO. 03-078

1 **WHEREAS, the Council did enact Ordinance No. 98-03, "Establishment of Tohono O'odham Ki:ki**  
2 **Association" ("TOKA Ordinance"), thereby establishing the Ki:ki Association and its**  
3 **five-member Board of Directors; and**

4 **WHEREAS, Article V, Section 1(a) of the TOKA Ordinance provides that "[T]he Board shall consist**  
5 **of five (5) voting members appointed by the Tohono O'odham Legislative Council";**  
6 **and**

7 **WHEREAS, with the passing of the late Clifford Pablo a vacancy exists on the TOKA Board; and**

8 **WHEREAS, the Tohono O'odham Legislative Housing Committee has oversight over housing**  
9 **matters and did interview candidates to fill the TOKA Board seat vacated by the late**  
10 **Clifford Pablo; and**


11 **WHEREAS, based upon the interview process, the Legislative Housing Committee recommends**  
12 **the appointment of Janice Aldrich to the TOKA Board of Directors beginning on the**  
13 **effective date of this Resolution and ending on the last day of February 2004.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**  
15 **hereby appoint Janice Aldrich to the Tohono O'odham Ki:ki Association Board of**  
16 **Directors to fill the seat vacated by the late Clifford Pablo.**

17 **BE IT FINALLY RESOLVED that Janice Aldrich's term shall begin on the effective**  
18 **date of this Resolution and shall end on the last day of February 2004 or until her**  
19 **successor is appointed.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day**  
21 **of FEBRUARY, 2003 at a meeting at which a quorum was present with a vote of 1,484.05 FOR; 708.6**  
22 **AGAINST; 80.35 NOT VOTING; and 144.5 [04] ABSENT, pursuant to the powers vested in the Council**  
23 **by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
