5		of five (5) voting members appointed by the Tohono O'odham Legislative Council";

7	WHEREAS,	with the passing of the late Clifford Pablo a vacancy exists on the TOKA Board; and
8	WHEREAS,	the Tohono O'odham Legislative Housing Committee has oversight over housing
9		matters and did interview candidates to fill the TOKA Board seat vacated by the late
10		Clifford Pablo; and
11	WHEREAS,	based upon the interview process, the Legislative Housing Committee recommends
12		the appointment of Janice Aldrich to the TOKA Board of Directors beginning on the
13		effective date of this Resolution and ending on the last day of February 2004.
14	NOW, THE	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
15		hereby appoint Janice Aldrich to the Tohono O'odham Ki:ki Association Board of
16		Directors to fill the seat vacated by the late Clifford Pablo.
17	BE IT FIN	IALLY RESOLVED that Janice Aldrich's term shall begin on the effective
18		date of this Resolution and shall end on the last day of February 2004 or until her
19		successor is appointed.
