6	WHEREAS,	by Resolution No. 02-562, the Nation approved a new tribal-state gaming compact					
7		with the State of Arizona; and					
8	WHEREAS,	the Gaming Office of the Tohono O'odham Nation recommends amendment to					
9		various provisions of the Gaming Ordinance, in the form attached hereto and					
10		incorporated herein by this reference, for consistency with the new compact; and					
11	WHEREAS,	the Gaming Authority of the Tohono O'odham Nation and the Commerce Committee					
12		and the Domestic Affairs Committee of the Legislative Council support the					
13		recommended amendments to the Gaming Ordinance.					
14	NOW, THEREFORE, BE IT RESOLVED THAT:						
15		1. The Gaming Ordinance is hereby amended in the form attached hereto.					
16		2. The Gaming Ordinance shall be reprinted in its entirety bearing Ordinance No.					
17		93-01 and showing a revision date of February 2003.					
18		3. The amendments to the Gaming Ordinance approved hereby shall be effective					
19		immediately, subject only to disapproval by the National Indian Gaming					
20		Commission.					
21		4. The Executive Director of the Gaming Office is authorized and directed to submit					
22		the amended Gaming Ordinance to the National Indian Gaming Commission for					
23		approval, and to take all other reasonable and necessary steps for					
24		implementation of this Resolution.
