

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting Legislative Council Standing Committee Attendance Procedure)**

**DEFEATED  
LEGISLATIVE ORDER NO. 03-087**

1 **WHEREAS, Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation empowers**  
2 **the Legislative Council "[T]o establish rules and procedures to regulate all meetings**  
3 **of the Tohono O'odham Council, standing committees, boards, and special**  
4 **committees"; and**

5 **WHEREAS, the Legislative Council has adopted Legislative Rules to regulate Representatives'**  
6 **compensation based, in part, upon attendance at committee meetings (Legislative**  
7 **Rules, Article X, Section 3.A.1.); and**

8 **WHEREAS, the Legislative Rules further provide that "Committee Officers shall verify the**  
9 **attendance of Legislative Representatives for Committee Sessions." (Legislative Rules,**  
10 **Article X, Sections 5.A.1.B.); and**

11 **WHEREAS, the nature and importance of the issues being addressed at committee meetings**  
12 **makes it essential that all committee members attend; and**

13 **WHEREAS, it is in the best interest of the members of the Tohono O'odham Nation that their**  
14 **Legislative Council Representatives be accountable for attending standing**  
15 **committee meetings in order that the people may be adequately represented; and**

16 **WHEREAS, the Rules Committee has developed the attached "Legislative Council Standing**  
17 **Committee Attendance Procedure," which is incorporated by this reference, to**  
18 **provide for such accountability and recommends its adoption.**

19 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**  
20 **hereby adopts the "Legislative Council Standing Committee Attendance Procedure."**

22 **The foregoing Order was presented to the Tohono O'odham Legislative Council on the 06<sup>TH</sup>. Day**  
23 **of FEBRUARY 2003 at a meeting at which a quorum was present, and by a vote of 1,027.95 FOR;**  
24 **1,113.9 AGAINST; 275.65 NOT VOTING; and [05] ABSENT, failed to pass because it did not receive a**  
25 **majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono**  
26 **O'odham Nation.**
