11		exterior boundaries of the Tohono O'odham Nation (the "After Acquired Trust Lands			
12		Provision"); and			
13	WHEREAS,	the After Acquired Trust Lands Provision was incorporated in the 2002 SAWRSA			
14		Amendments which were approved for introduction in Congress as Title III of the			
15		2002 Act pursuant to Legislative Council Resolutions 02-232 and 02-366; and			
16	WHEREAS,	the 2002 SAWRSA Amendments were introduced in Congress as Title III of the 2002			
17		Act; and			
18	WHEREAS,	no action was taken by Congress on the 2002 Act; and			
19	WHEREAS,	the SAWRSA Task Force has presented for approval of the Legislative Council a			
20		January 31, 2003 marked draft of the Southern Arizona Water Rights Settlement			
21		Amendments Act of 2003 (the "2003 SAWRSA Amendments") as Title III of the Arizona			
22		Water Settlements Act of 2003, a copy of which is attached hereto; and			
23	WHEREAS,	the SAWRSA Task Force has presented for approval of the Legislative Council a			
24		February 5, 2003 draft of the Tohono O'odham Settlement Agreement (the "2003			
25		Settlement Agreement"), and exhibits thereto; and			
26	WHEREAS,	the Water Resources Committee recommends approval by the Legislative Council of			
27		the 2003 SAWRSA Amendments and the 2003 Settlement Agreement.
