

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting Hearing on Removal Accusation Filed Against Chairman Edward D. Manuel)**

**LEGISLATIVE ORDER NO. 03-096**

1 **WHEREAS, on January 9, 2003, Delma Garcia and Sells District Chairman Norbert Manuel, who**  
2 **are both registered voters of the Tohono O'odham Nation, filed a Petition for Removal**  
3 **From Office ("Accusation") with the Chairperson of the Judiciary Committee against**  
4 **Edward D. Manuel, Chairman of the Tohono O'odham Nation, in accordance with the**  
5 **provisions of Section 2 of Article IX of the Uniform Election Ordinance; and**

6 **WHEREAS, the Judiciary Committee has held a hearing upon the Accusation in accordance with**  
7 **Section 2(C) of Article IX of the Election Ordinance and, by Judiciary Committee**  
8 **Resolution No. 03-07, did determine that there is reasonable cause to believe that**  
9 **Edward D. Manuel, Chairman of the Tohono O'odham Nation, has committed a**  
10 **removable offense as charged in the Accusation; and**

11 **WHEREAS, the Judiciary Committee did file the Resolution and the Accusation with the Secretary**  
12 **of the Legislative Council in accordance with the provisions of Section 2(D) of Article**  
13 **IX of the Uniform Election Ordinance; and**

14 **WHEREAS, the Legislative Council has previously adopted "Legislative Rules of Procedure Upon**  
15 **Accusation for Removal" ("Removal Procedure") pursuant to Legislative Order No. 03-**  
16 **054; and**

17 **WHEREAS, the Uniform Election Ordinance requires that the Legislative Council set a hearing**  
18 **on the Accusation.**

19 **NOW, THEREFORE, BE IT ORDERED by the Legislative Council that a hearing on the**  
20 **Accusation against Edward D. Manuel, Chairman of the Tohono O'odham Nation,**  
21 **shall be held on March 17, 2003, at 9:00 a.m., in the Council Chambers in Sells,**  
22 **Arizona.**

23 **BE IT FURTHER ORDERED that, in accordance with Article IX, Section 2(D) of the Uniform**  
24 **Election Ordinance, the Secretary of the Legislative Council shall cause a copy of the**  
25 **Accusation, Judiciary Committee Resolution No. 03-07, the Removal Procedure, and**  
26 **this Legislative Order, to be served on the Accused forthwith and not less than ten**  
27 **days before date set for the hearing.**

28 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day of**  
29 **FEBRUARY 2003 at a meeting at which a quorum was present with a vote of 1,750.9 FOR; 441.75**  
30 **AGAINST; 80.35 NOT VOTING; and 144.5 [03] ABSENT, pursuant to the powers vested in the Council**  
31 **by Section 1 (a) and 1(l) of Article VI and Article XIII of the Constitution of the Tohono O'Odham**  
32 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
34 **of the Act of June 18, 1934 (48 Stat. 984).**


