
1 **WHEREAS, the following named person(s) have formally relinquished their membership in the**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day**
12 **of MARCH 2003 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0- AGAINST;**
13 **-0- NOT VOTING; and 160.7 [04] ABSENT, pursuant to the powers vested in the Council by Article II,**
14 **Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted**
15 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
16 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
17 **18, 1934 (48 Stat. 984).**






