

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2004 Title VI, Part A Budget)

RESOLUTION NO. 03-104

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Program has been made possible in**
4 **part by Title VI of the Older American's Act of 1978 as amended; and**

5 **WHEREAS, the Title VI Part-A budget of \$132,850 has been prepared to cover the second year of**
6 **a three-year project; and**

7 **WHEREAS, the second year of the three year project covers April 1, 2003 through March 30, 2004**
8 **for Title VI, Part-A; and**


9 **WHEREAS, the Title VI, Part-A is requesting approval of the Fiscal Year 2004 Budget of \$132,850**
10 **and the expending of funds from April 01, 2003 through March 30, 2004.**

11 **NOW, THEREFORE, IT BE RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **approves:**

- 13 **1. The FY 2004 Title VI, Part A Budget of \$132,850 and the expending of funds from**
14 **April 01, 2003 through March 30, 2004.**
- 15 **2. The Tohono O'odham Nation officials, to wit: The Chairman is hereby authorized**
16 **to negotiate and execute the grant, provided however, that any amendments**
17 **affecting the funding or funding levels of this contract shall be submitted for**
18 **further prior approval by this Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD Day**
20 **of MARCH, 2003 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and 160.7 [04] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**




